Why Authorize?



Authorizing us as your representative with the CRA will allow us to check the status of your returns, file amendments, check for missing tax slips, and handle any audit or review requests with ease.

Personal Authorization

For personal authorization there are two methods.

1) You provide us with your personal information and we create an Authorization Form that you would sign.

2) You log in to your My Account with CRA and add us as an authorized representative. This guide outlines how to do this.



Business Authorization

Businesses can no longer opt to sign the Authorization Form and must instead authorize us through the CRA My Account.

If you do not have a My Account set up - please contact us or see our "Setting Up CRA My Account" guide to get started.



01 Log In To Your CRA Account



If you have a business your log in screen will ask you to select which account you would like to view, personal or business. If you do not have a business you should be taken to the next screen.
